## COVERAGE INCLUDES:

### FOOD & BEVERAGE STAINS such as

- barbecued ribs
- blueberries
- mustard
- chili
- chocolate
- juice
- ketchup
- meatballs
- nacho cheese
- olive oil
- ice cream
- wine

### COMMON STAINS such as

- cosmetics
- suntan lotion/oil
- ink/marker
- bleach or chlorine

### HUMAN & PET BIOLOGICAL STAINS such as

- blood
- saliva
- urine
- vomit

*Accumulation of stains, soil build-up over time, perspiration, hair and body oils are not covered by this plan.*

### ACCIDENTAL DAMAGE

on fabric upholstered areas, cushion sets, umbrellas, fabric gazebos, or cover slings such as

- cigarette burn
- broken chair weld
- broken table top
- puncture from silverware
- damaged rocker/swivel mechanism
- propane fire pit malfunction
- heat mark from pan
- rip from broken glass
- stone table chip
- broken umbrella mechanism
- knife cut through to cast aluminum
